## BIDDERS LIST FORM

**Collection of the information noted by an asterisk (\*) is required by the U.S. Department of Transportation, 49 C.F.R. § 26.11.** A Disadvantaged Business Enterprise (DBE) is a for-profit small business concern: (1) that is at least 51 percent owned by one or more individuals who are both socially and economically disadvantaged; and (2) whose management and daily business operations are controlled by one or more of the socially and economically disadvantaged individuals who own it.

**Effective October 3, 2025, each Unified Certification Program (UCP) must reevaluate currently-certified DBE firms and issue a written decision with respect to each such firm indicating whether such firm is recertified or decertified under the Department's new certification standards. 49 C.F.R. § 26.111. Therefore, do not identify your firm or any subcontractor as a DBE unless the firm has been issued a written decision recertifying it as a DBE under the new certification standards.**
