NON-DISCLOSURE AGREEMENT

Pentagon Force Protection Agency (PFPA)

Subject: Certification of Nondisclosure

Reference: Solicitation No.: HQ003426RE045

In performance of work with the United States Department of Defense (DoD), Pentagon Force Protection Agency (PFPA), the undersigned individual agrees that all information or materials pertaining to the DoD Integrated Security Services Contract (5), made available by the United States Government, or that the contractor has access to by virtue of the provisions of this contract, that relate to the business or resource needs of the United States Government, or other information not intended for public disclosure, shall be deemed to be "sensitive, confidential, and/or proprietary." He/she shall keep in confidence and protect from unauthorized disclosure any such materials or information. This includes disclosure of confidential information to individuals who are not specifically assigned to work on this program, and who have not signed this or a similar agreement, including other members of his/her corporation.

The undersigned further certifies that he/she will not discuss with, or reveal to, any representative of any organization or other entity, or any individual person (except persons specifically assigned to the specific work detail) either within or outside the United States Government, any aspect of the pending procurements. The term "pending procurement" includes, but is not limited to, information such as the identity and number of contractors, the method of procurement, the number and identity of United States Government personnel involved, and the key procurement information (e.g., pricing and proprietary data) or schedules or implementation of events. He/she also agrees to not discuss with, or reveal to, any representative of any organization or other entity, or any individual person (except persons specifically assigned to the specific work detail) either within or outside the United States Government "nonpublic information", which includes such information labeled as Controlled Unclassified Information (CUI), nonpublic financial execution or planning information, proprietary information (e.g., information submitted by a contractor marked as proprietary), advanced procurement information (e.g., future requirements, statements of work, and acquisition strategies), source selection information (e.g., bids before made public, source selection plans, and rankings of proposals), trade secrets and other confidential business information (e.g., confidential business information submitted by a contractor), attorney work product, information protected by the Privacy Act (e.g., social security numbers, home addresses and telephone numbers), and other sensitive information that would not be released by the PFPA under the Freedom of Information Act (FOIA).

The undersigned agrees that any such confidential materials and/or information shall not be used except in the performance of duties as otherwise directed by the United States Government. The undersigned further affirms that in the event any business entity, either as prime or subcontractor, in which he/she, or a member of his/her family or household, have holdings, financial interest, or an employment relationship, of whatever nature and to whatever extent, has submitted a proposal in response to a requirement to PFPA, that he/she will notify the Contracting Officer at the site to which he/she is assigned in writing.

At the completion of his/her support under this contract or the completion of this contract, whichever comes first, he/she will return all documents, electronic files, etc. to the responsible Government Project Officer. This agreement shall be effective for the period commencing with the execution of this Agreement and ending upon "Completion of Contract". The obligation imposed by this Agreement shall survive the expiration or termination of the Agreement.
