THIS CONTRACT for the provision of **CONTRACT NAME** ("Contract") is entered into this _____ day of _____, 202_, by and between the **County of Montgomery ("County")**, **OPTIONAL: acting through CONTRACTING DEPARTMENT**, and **CONTRACTOR NAME ("Contractor")**.

WHEREAS, The County issued a Request For Proposals ("RFP")/Invitation To Bid ("ITB") for the provision of **CONTRACT NAME** for County, RFP/ITB No. #####; and

WHEREAS, Contractor submitted a proposal/bid in response to the RFP/ITB; and

WHEREAS, the County Commissioners determined that Contractor's proposal was the most advantageous to the County after taking into consideration all of the evaluation factors set forth in the RFP and selected Contractor for award; and

WHEREAS, the County Commissioners determined that Contractor's bid was the lowest cost that was both responsive and responsible and selected Contractor for award; and

WHEREAS, the County Commissioners determined to contract with all responsive and responsible vendors that submitted; and

WHEREAS, the County Commissioners memorialized the award through the passage of Resolution No. #####, and

WHEREAS, County and Contractor have negotiated this Contract as their final and entire agreement in regard to providing **CONTRACT NAME** to the County.

NOW THEREFORE, intending to be legally bound hereby, County and Contractor agree as follows:

1. The Term of this contract shall be for **TERM**.
2. Contractor shall, in accordance with the terms and conditions of this Contract, provide **CONTRACT NAME** to the County as more fully defined in the attached Statement of Work, attached hereto as Exhibit B, and the corresponding Montgomery County Procurement Portal, including all posted questions and answers, addendums, drawings etc.

3. Contractor agrees to provide the **CONTRACT NAME** at the price listed in its **Bid/Cost Submittal**, which is attached hereto as Exhibit C.
4. The County's Standard Terms and Conditions contained in Exhibit A shall apply to this contract.
