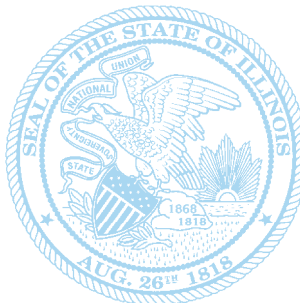

## ILLINOIS DRIVE AWAY VEHICLE PERMITS CUSTOMER INSTRUCTIONS

- 1.) Permits may only be issued if the applicant has provided proof of ownership to the issuing agency.
  - 2.) Illinois Resident Permit (Intrastate) 7-Day Expiration: This permit may be used to operate a non-registered vehicle for seven days upon issuance. Proof of ownership must be verified when issuing an intrastate permit. Only three permits are allowed per vehicle per year. The permit must display an Illinois address.
  - 3.) Non-Resident Permit (Interstate) 90-day Expiration: This permit may be used to operate a vehicle being driven to another state for 90 days upon issuance. Ownership documentation must indicate an out-of-state address when issuing a Non-Resident Drive Away Permit. Only one permit is allowed per vehicle per year. The permit must display an out-of-state address.
  - 4.) Permits are void if any information is missing or altered.
  - 5.) After the permit is filled out, the top part of the permit is placed in the upper left rear window of the vehicle being operated. This side of the permit is to face the passenger compartment.
  - 6.) For permits to be valid, all trucks and trailers must be operated on empty weight.
  - 7.) "Special 90-Day Permit" will print on the 7-Day Permit.
- Operation of a vehicle with the permit requires the vehicle to be covered by the appropriate mandatory liability insurance coverage.

## ILLINOIS DRIVE AWAY VEHICLE PERMITS

The Secretary of State issues quantities of Drive Away Vehicle Permits to licensed vehicle dealers and remitters for \$10 each (7-Day) and \$27 each (90-Day). Dealers selling vehicles to non-residents may issue permits and deliver vehicles at their Illinois place of business without incurring Illinois tax liability. Dealers are not authorized to transfer permits from one dealer to another. Each dealer is assigned numbered permits and is responsible for all permits issued to the dealership. Dealers and remitters are to retain records of Drive Away Vehicle Permits for three years.
